SUBMISSION RULES AND INSTRUCTIONS

- 1. Fill in your name, address, phone number and email in the space provided. Please note, we are unable to ship to P.O. Boxes.
- 2. List a description for each item with authentication fee, found at Beckett-Authentication.com. For lines listing a quantity greater than one, enter the total declared value for all items in the "Declared Value" column.
- 3. Calculate Subtotals of Fees.
- a.Letter Upgrade By choosing encapsulation, the certificate/letter of authenticity and tamper-evident label are forfeited, unless the customer requests both for an additional fee of \$10 per item.
- b. Autograph Grade Once the autograph is deemed authentic, it can then be graded based on the condition of the autograph using a scale of 1-10. Please note, the grade reflects the condition of the autograph only.

- c.**Card Grading** Given that the autograph is authentic, the card can then be graded based on its condition for a fee of \$10 per card. Please note, both the autograph and the card must receive a grade in order to use this service, additional autograph grading fees apply. Cards that have been certified directly through the manufacturer can be submitted on a Beckett Grading submission form.
- d.Oversize Surcharge- Items that are 5"x7" or larger are subject to an oversize surcharge of \$8 per item.
- e. Baseball Encapsulation- Baseballs can be sealed in our unique tamper-evident case for a fee of \$30 per baseball.
- f.Insurance- Insurance costs applies to all carriers and is based upon the declared value of the package.

- 6. Place each item in a semi-rigid holder such as a "Card Saver 1". Do not use screwdown or hard acrylic holders. Beckett Authentication Services will not be responsible for any damages incurred by the use of improper holders.
- 7. Items must be accompanied by a Beckett Authentication Services submission form. Failure to completely and accurately fill out the proper submission form may result in delayed turnaround times or additional charges.
- 8. Ship Your Items to: Beckett Authentication Services, 4635 McEwen Road, Dallas, TX 75244. All items must be sent insured with a tracking number, we will not be responsible for uninsured packages.

Terms and Conditions:

- 1. All terms and conditions are subject to change.
- 2. All fees paid to Beckett Authentication Services are NON-REFUNDABLE once the item begins the authentication process.
- 3. Certification and authentication involves an individual judgement that is subjective and requires the exercise of professional opinion, which can change from time to time. Therefore, Beckett Authentication Services makes no warranty or representation and shall have no liability whatsoever to the customer for the opinion rendered on any submission.
- 4. Beckett Authentication Services shall have no liability whatsoever to the customer for any damage to any items that Beckett can reasonably demonstrate occurred while not in the custody or control of Beckett. However, if Beckett determines the customer's submission was lost or damaged while in Beckett's possession, customer will be compensated based upon the fair market value of the submission as determined by Beckett's standard procedures which may include filing a claim with our insurance carrier. The owner's declared value is used for determining insurance cost of the return shipment and the maximum amount that can be claimed for damage or loss in shipment for any items. IN NO EVENT SHALL THE TOTAL LIABILITY EXCEED THE DECLARED VALUE OF THE ITEM.
- 5. Trading cards encased without an actual grade for the card does not verify that the card is authentic or unaltered. To determine if card is authentic and/or unaltered, both the autograph and the card must receive a grade.
- 6. Beckett Authentication Services will provide collectors with the finest, most thorough, consistent and accurate authentication efforts available in the industry. Occasionally an item may have a typographical error on the label or certificate/letter of authenticity. Customer agrees to return any incorrectly described item to Beckett upon request at any time, and agrees to indemnify and hold harmless Beckett and its affiliates against all losses and/or claims (including attorney's fees) caused by the circulation or sale of a mismarked or inappropriate item or any unauthorized use of a Beckett certificate or label.
- 7. Beckett will not be responsible for returning items sent with insufficient payment or inadequate contact information, nor will Beckett be required to contact you or retain your items in such circumstances for a period in excess of three (3) months from its initial receipt.
- 8. The rights and obligations of both you and Beckett shall be governed by and construed in accordance with the laws of the United States and the State of Texas, excluding its choice of law rules.
